Rescue Swimmer Awarded DFC for Daring SAR Response



Aviation Survival Technician Second Class Spencer T. Manson received the Distinguished Flying Cross Award at Coast Guard Sector/ Air Station Humboldt Bay on December 12, 2023.

Manson received the award for his heroic efforts during a rescue operation on June 19, 2021, which occurred 70 miles offshore from the California—Oregon border, resulting in all six persons lives aboard a disabled 79-foot schooner being saved.

The prestigious Distinguished Flying Cross Award is the highest honor that can be achieved in aviation and is awarded to any Navy, Marine Corps, or Coast Guard personnel who distinguish themselves for heroism or outstanding achievement while participating in aerial flight.

Original press release from the June 19, 2021 incident

MCKINLEYVILLE, Calif. —On the afternoon of June 19, 2021, Coast Guard Sector Humboldt Bay received a VHF distress call from the crew of the yacht *Barlovento*, a classic 79-foot schooner with a storied pedigree. In a severe storm off the Oregon-California border, the wooden vessel was disabled and taking on water. One of the six crewmembers had sustained injuries to her head and arm.

The situation was urgent, as the conditions on scene were rough, with winds of 60 miles an hour and seas of 20 feet. Watchstanders launched a fixed-wing aircraft out of Air Station Sacramento to provide overwatch and a Sector Humboldt Bay Dolphin helicopter crew. The Dolphin crew arrived on scene and deployed their rescue swimmer, Petty Officer 3rd Class Spencer Manson.



The yacht's motion and the running seas were too severe to land Manson on deck, so the crew picked an unusual course of action: they dropped him in the water downwind of the *Barlovento*, knowing that the yacht would blow past him at speed. It did, making nine knots, and Manson grabbed hold of a trailing line in the water. In a scene readymade for Hollywood, he pulled himself

hand over hand against the current and climbed aboard the yacht from the stern. The motion slammed him into the water multiple times.

Once aboard, Manson got the injured crewmember prepared for hoisting. It was still not possible to hoist someone off the deck of the pitching yacht, so both the rescue swimmer and the victim had to jump into the water. Once clear of the *Barlovento*, Manson helped the victim into a rescue basket, and the aircrew hoisted her up and flew her to shore.

Manson returned to the *Barlovento* and helped safely hoist three more people, using a "sliding-deployment technique" of his own devising that let him hang off the boat to help the survivors into the water for retrieval. Another aircrew and rescue swimmer flew out to get the last two survivors. The *Barlovento* was left to drift in the storm.

Coast Guard Uses VHF Direction-Finding to Rescue Two Fishermen

"On Tuesday, December 19, the U.S. Coast Guard safely rescued two fishermen off the coast of Charleston, South Carolina after their vessel capsized and sank.

At about 2030 hours on Tuesday night, Coast Guard Sector Charleston received a mayday call over Channel 16 from a crewmember aboard the vessel, a 30-foot fishing boat. The boat was taking on water and going down, the caller reported.

The Coast Guard dispatched a boat crew and a helicopter crew to help, and watchstanders used bearings of the vessel's last VHF transmission to triangulate the location of the casualty. This direction-finding technique is a classic search method, less used in the age of the satellite EPIRB but still relevant - and accurate. The helicopter aircrew transited to the triangulated position and immediately spotted a life raft with two survivors on board.

In a statement, Sector Charleston said that having a VHF marine radio was a critical factor in the positive outcome of the SAR mission. "The mariners were able to provide us with a chance to find them by using their marine grade radio and we utilized our search and rescue technology to pinpoint their last known location that was provided to our aircrew," said Lt. Michael Allen, Coast Guard Sector Charleston's search and rescue mission coordinator.

The aircrew deployed their rescue swimmer, who brought the two men aboard safely. The survivors were delivered to Medical University South Carolina for evaluation and further care."

USCG New Online "Launch and Recovery" Charting App Provided by Hans Hoffman, CAPCA Vice-President Captains, indeed, all mariners planning a DELMARVA circumnavigation or cruises to points south, will soon have an additional charting tool available. This charting app will provide space launch and re-entry information off the east coast, including Wallops Island, Virginia. This is how the U.S. Coast Guard has recently announced the new app:



COMING SOON: NAVCEN will be releasing our new Space Operations Launch and Recovery (SOLAR) geospatial visualization tool in the near future. The initial build of this tool will be available in the Coast Guard Seventh District with further expansion in 2024.

SOLAR will offer a practical solution for mariners and the shipping industry to access real-time, geospatial information about space launches and reentries. This information is critical for navigating safely in areas affected by space operations. The tool will be available online at www.navcen.uscg.gov, providing an accessible platform for users to stay informed.

Key features of the tool include:

- 1. Interactive Display: A visual format for easier understanding of restricted navigation areas.
- 2. Updated Information: Timely data on space launches and reentries to help mariners make informed decisions.
- 3. Online Accessibility: The tool is readily accessible on the NAVCEN website.

This tool will align with NAVCEN's goals to modernize maritime communications and provide relevant, up-to-date information to mariners and other stakeholders.

Joint Effort to Explore New Wind Energy Areas Off MD Coast

gCaptain, December 11, 2023

Members of the Biden Administration, along with various departments and officials, have announced a joint commitment to evaluate additional areas off the coast of Maryland that could potentially support offshore wind energy projects.

The collaboration includes the Department of the Interior, Department of Defense, National Oceanic and Atmospheric Administration, U.S. Coast Guard, National Aeronautics and Space Administration, as well as U.S. Senators Ben Cardin and Chris Van Hollen, and Maryland Governor Wes Moore.

Under the joint commitment, the administration and the State of Maryland will work together to advance the review of these areas, aligning with the goals of Maryland's Promoting Offshore Wind Energy Resources Act. They will also consider how federal and state efforts can address any necessary mitigation related to existing offshore activities. These efforts are part of the broader plan by the Biden administration to boost the American offshore wind industry, aiming to deploy 30 gigawatts (GW) of offshore wind energy capacity by 2030.

Here are the classes scheduled for spring 2024:

SKYWARN and Weather-Ready Nation Ambassadors training, presented by the National Weather Service (NWS)

Date & Time TBD

This course will help all of us get better at understanding the weather we are experiencing and partner with the NWS to keep them updated on our observations. This training will be held at the NWS Baltimore/Washington Forecasting Station in Sterling, VA and will include a tour of their facility.

Marine Radio Operator Permit Class with Optional FCC Certification and Exam

March 9, 2024 0900 - 1500 Selby Bay Yacht Club

Member Cost: \$115 wo/Certification - \$190 w/Certification

Minimum 6 students

This class is designed to learn VHF and HF radio operations and regulations for the Small Passenger Vessel (SPV) industry. This class will also prepare you to take and pass the FCC Element 1 exam which will earn you an FCC Marine Radio Operator Permit (MROP), which is required for most inspected SPVs.

License Renewal March 10, 2024 Selby Bay Yacht Club

Besides being a fantastic review for all boaters, this course satisfies the professional requirement of attending an approved training course in lieu of the 360-sea day requirement as outlined in 46 CFR Part 10.227 (Requirements for Renewal). This renewal class is for MMC renewals for Operator of Uninspected Passenger Vessels (OUPV) and 100-Ton Master for both Inland and Near Coastal waters. A certificate of completion will be issued to students who attend all required classroom training and who successfully pass the written proctored exam. The completion certificate will be

submitted with the MMC renewal application and will be in-lieu of the 360-sea day requirement for renewal. Course completion certificates will be valid for one year.

CPR/AED and First Aid for Boaters March 16, 2024

Selby Bay Yacht Club

This CPR/AED and First Aid Course is designed especially for boaters. The program is taught by American Heart Association Certified Instructors.

Upon completion of the training, students will receive an American Heart Association Course Completion Card in CPR & First Aid. This certification card is accepted by ABC for anyone needing certification for BOC and by the USCG for Captain's License requirements (Optional segments required). It has a two-year expiration date.

Leadership for Captains

April 6, 2024 9:00 AM - 4:00 PM

Selby Bay Yacht Club Member Cost: \$140

Minimum 12 students

This program will be conducted by a professional leadership, team building and executive coaching consultant who has worked in over 150 private and public companies. More information on this class is included in the LOG.


An Interview with Captain Mike Clark

How did you get into boating? That's a funny story. My dad was in the Navy and we were living in Japan at the time. My friend and I were nine years old, spied a boat, and took it for a spin. A nearby sailor saw us, yelled at us, got us

back to the base, and then told my dad. I was in lots of trouble but it made for a memorable first boating experience!

What was your next boating adventure? After I graduated James Madison University, my girlfriend moved to the beach for a summer job. I followed her and got a job on a commercial fishing boat near Barnegat Light, NJ. When summer ended, she went back to JMU and I kept fishing. The work is dirty and dangerous but it's pretty cool to venture 200 miles offshore for up to ten days. I've always said, "it's the hardest job you'll ever love."





Does your wife like the water, too? Yes! While we were working our careers and raising our family in Manassas, VA, we started a boat fund with loose change in a five-gallon jar. Safety Snapshot - The Importance of Safety Training in Maritime Work

"In the vast expanse of the world's oceans and waterways, maritime workers face unique challenges that most land-based workers would never encounter. From weather conditions and treacherous seas to complicated

machinery operations, maritime workers grapple with elements that require a specialized knowledge base. Safety training in the maritime sector isn't just crucial—it's a matter of life and death."

It is essential to have a plan and practice for man overboard incidents, recognizing signs of fatigue, storm avoidance, hurricane preparedness and evacuation, and dealing with equipment failures.

"Maritime safety training shouldn't be seen as just another checkbox on a compliance form. It's [a captain and] employer's moral and legal obligation to ensure their crew is prepared for any eventuality. Proper training can mean the difference between a close call and a tragedy."

Uninspected Passenger Vessel Exams

CAPCA member Bruce Johnson is a USCG Licensed Master, as well as a member of the U.S. Coast Guard Auxiliary designated as a UPV examiner. Captain Johnson is available to do Uninspected Passenger Vessel exams for those who want them. Members can request UPVEs or ask questions any time by emailing him at bruce.johnson@cgauxnet.us or calling 410.707.1682 and leaving a message.

Voluntary UPV examinations are available to assure that owner / operators comply with federal regulations. If the vessel passes a UPV exam a decal is issued. Since this is a voluntary dockside exam, it is not a law enforcement action, and no citations are issued. On the other hand, passing a UPV exam does not absolutely guarantee that the vessel may not be boarded when it is underway.

Uninspected Passenger Vessels (UPVs) are vessels not subject to Coast Guard inspection that are less than 100 gross tons with 6 or fewer passengers, including at least one passenger for hire. UPVs may also include vessels over 100 GTs but less than 300 GTs that carry not more than 12 passengers, with at least one being a passenger for hire. All UPVs must be under the direction and control of an individual credentialed by the Coast Guard. The original license or Merchant Mariner Credential (MMC) must be aboard and available for immediate presentation to CG officials whenever

passengers are being carried for hire. There are additional equipment and performance requirements for UPVs.




Membership Renewal Reminder

Website Spotlight




You may have noticed that the CAPCA public and members' web pages have a new look: the website update shows new headers and page appearance but with the same information.

The web team works to make your website a timely resource that's both informative and useful. It's kept up to date and new material is added to keep

the site current. This column will help you get familiar with some of the website's features.

Please **bookmark** the **member login page** on all your devices so you can go right to the member side of the website. The member's pages have more information than the public pages. Everything you are likely to need is on the member side, but occasionally take a look at the public side, to see what the rest of the world sees.



The display on your device may not look exactly like this, but the menu tabs are the same. Smaller screens may have a "hamburger menu."

Use the CAPCA "Web Resources" menu tab for quick access to websites you may need. No Googling to find a website or keeping a lot of bookmarks on your devices. This menu tab is one of the most useful features of your website.

Some of the lists on the **Web Resources** tab have more items than can be shown on one page, so we recommend that when you go to a category list, you select "All" in the small box on the right with the down arrow.

CAPCA's Crew Registry Program

Captains: Looking for licensed crewmembers for a delivery job, an assignment as an instructor, or any other on-the-water venture?

Crewmembers: Looking for a slot as a crewmember, either for pay or to gain experience?



Either way, CAPCA's CREW REGISTRY program can help you. Here's how it works:

- If you're a CAPCA member who'd like to serve as a crewmember for another CAPCA member, fill out and submit the crew registry sign-up form on the member side of the website. Your name and the information about your interest and qualifications will appear on the Crew Registry list.
- 2. **IMPORTANT: Note these two questions** on the signup form, "Currently enrolled in a U.S. Coast Guard-recognized random drug screening program?" and "Name of drug screening program."

Your answers to these questions should **reflect** *your current status*. You DO NOT have to be enrolled in a drug screening program unless your work as a captain requires it. If you're **not** in a screening program, answer "NO" and "NONE" to the questions. If you **are currently** enrolled in drug screening program, answer "Yes" and enter the name of the program in the box.

A captain seeking crew may need a crewmember who is currently enrolled in a drug screening program, so it's important to indicate if you are or are not in a screening program.

When you renew your license (and in some other employment situations), a drug *screening test* is required, as the Coast Guard specifies: "A drug test is required for all transactions EXCEPT documents of continuity modifications (increases of scope), duplicates, and International Endorsements (STCW)."

However, a number of captains do the drug screening test just for license renewal, and if their employment as captains does not require enrollment in a drug screening program, they do not enroll after the test.

- 3. Captains **looking for crew**, log in to the member side of the CAPCA website and examine the crew registry list to see the available crew listings. The most recent postings appear at the top of the list.
- 4. If a captain is interested, he or she can contact you directly and you two can work out arrangements for duties and pay.

- 5. The list of members who have signed up for crew duty will remain available indefinitely. The list will form a crew registry to which captains can refer time after time.
- 6. Editing your information: If any of the information you filled out on your registry form changes, or if you no longer want to be included on the Crew Registry list, you can edit or delete your listing yourself. Log in with your member username and password, click the CREW REGISTRY menu item and the blue "Edit Your Listing" button. You will see four icons to the right of your listing for viewing, editing, deleting, or downloading. You can hover your cursor over each icon to see what it does.
- 7. If you are on the Crew Registry, this might be a good time to **review your listing**. If any of your information has changed, you can update it with immediate results. If you are no longer interested in being listed on the Crew Registry, please delete your listing.
