### MAJOR ISSUES & OBJECTIVES

•Reduce agricultural pollution in the waterways of the Chesapeake Bay and coastal watersheds to ensure the success of the Chesapeake Bay TMDL.

•Reduce urban and suburban polluted stormwater runoff to ensure that urban and suburban streams become fishable and swimmable once again and to ensure the success of the Chesapeake Bay TMDL.





# MAJOR ISSUES & OBJECTIVES, CONT.

 Raise awareness of the impacts of fossil fuels on local waterways by showing people and communities the immediate threats and cumulative impacts of fossil fuel extraction, storage and transportation, waste products and disposal, related infrastructure development, and legacy issues such as abandoned mine drainage. Raise awareness of how waterways and watersheds are changing due to current and long-term changes in climate.



•Chesapeake Bay TMDL. Engage at key decision points in the TMDL process and focus advocacy on EPA Chesapeake Bay Program, Region III, and federal appointees, exclusively.
